



## **TERMS AND CONDITIONS**

1. The sender understands and agrees with all the following terms and conditions herein.
2. The following are prohibited for shipment; Weapons, Drugs, Combustible Goods and Illegal Items, Ammunition, Explosion Materials and any material which may be hazardous and dangerous goods will not be shipped.
3. Prohibited for shipment under the definitions of the Philippine Bureau of Customs are commercial goods or goods that have to be taxed with import tax like goods in commercial quantities, gasoline motors, motorcycles, etc.
4. Discovering of prohibited or illegal items may lead to confiscation by customs authorities and the sender is liable and accountable to pay for the corresponding charges imposed by the Philippine Government.
5. The BOX MEASUREMENT = **80x55x50** must not be extended or deformed due to overpacking otherwise additional charges will apply accordingly. Every box must be properly closed.
6. Damage claims of any loss items; the COMPANY shall be liable only for the amount that is officially declared by sender. However the amount should not exceed of 200€. Any complain the sender should inform **C & E Balikbayan Box** within 24hrs from the date of delivery in form of either written or email to [info@c-and-e-balibayan-box.de](mailto:info@c-and-e-balibayan-box.de). After the allotted time no more claims will be entertained.
7. Only items listed on the packing list can be issued of compensation. Claims that are not in the packing list are not eligible for settlement.
8. Damages to the box and its contents due to any kind of liquids packed inside the box is not covered by insurance and will be entirely the risk of the sender.
9. Fully paid boxes will only be delivered!

### **Carrier's Obligations:**

1. C&E Balikbayan Box Service includes pick-up of boxes, storage and transport by ship release from Bureau of Customs, Philippines and deliver the boxes address written in the Export Declaration and Packing List signed by the sender.
2. C&E Balikbayan Box Service should inform the senders few days before the pick-up of the boxes. IMPORTANT NOTE: All personal data's provided to us in connection with this C&E Balikbayan Box Service will not be given/forwarded to the third parties in order to ensure the sender's privacy.

### **Sender's Obligations:**

1. The sender must ensure to offer for transportation properly packed boxes only which boxes will not contain undeclared, restricted, dangerous materials and illegal or banned items.
2. The sender must pack her/his personal belongings/effects properly and ensure that NO case be held liable for any breakage, damages that may be caused in handling or shipping the same.
3. The sender must fill out completely and sign the Export Declaration and Packing List legibly with correct address and telephone numbers.

IMPORTANT NOTE: Upon delivery, the sender must inform his/her consignee to check the boxes and contents and indicate conditions of delivered boxes in the remarks area of Official Receipt received from the furnisher.
